Partner Agency Roles and Responsibilities

July 2021

Background

The GBV Resource Database is a centralized, comprehensive, and up-to-date database of domestic violence, sexual assault, human trafficking and commercial sexual exploitation services across King County and surrounding counties. Through the robust Visionlink platform, this database will increase access to services, streamline referral processes and overall, provide more robust, wraparound support to survivors in the region. The collaborative nature of the database will strengthen relationships between service providers, allowing for increased coordination and co-advocacy.

Roles

The Coalition Ending Gender Based Violence will fulfill the following role to maintain a well-functioning database:

1. Convene partner agencies on a regular and as-needed basis to foster relationship and communication amongst providers.
2. Serve as a feedback channel between the DVHopeline, the DV Coordinated Housing Access Point and partner agencies to ensure seamless communication and continuous improvement.

Partner Agencies will fulfill the following role to maintain a well-functioning database:

At initial rollout:

1. Confirm agency and service information.
2. Make appropriate changes to resource record within a reasonable timeframe.
3. Populate the "Option Lists" as part of the service information.
4. Train all relevant staff within their agency on how to use the new database.

On an ongoing basis:

1. For those with shelter space, update daily 10a.
2. For those with shelter space, update when there are space changes.
3. For all other services, update regularly and when prompted.
4. Attend regularly and be in regular contact with the Coalition Ending Gender Based Violence for updates.
5. Provide ongoing training and support to staff within their agency on an ongoing basis.
6. Use and share user information and password to the resource database appropriately.
